

**LIMITED USE LABEL LICENSE AGREEMENT (“LULL”)  
FOR CELLS OFFERED BY AGATHOS BIOLOGICS**

BEFORE ORDERING OR USING THIS PRODUCT, PLEASE READ THE TERMS AND  
CONDITIONS SET FORTH IN THIS LULL. YOUR ORDER PLACEMENT OR USE OF  
THIS PRODUCT SHALL CONSTITUTE ACKNOWLEDGMENT AND ACCEPTANCE OF  
THESE TERMS AND CONDITIONS.

In this LULL the following shall mean:

“Licensed Materials”: are the Product, Progeny, Modifications, or Derivatives.

“Licensee”: the individual or legal entity purchasing the Product.

“Product”: the cell(s) received by Licensee from Agathos Biologics under the terms of this LULL.

“Progeny”: any unmodified descendant form of the Product.

“Modifications”: any modifications of the Product or Progeny.

“Derivatives”: any substances which constitute a sub-unit or component of the Licensed Materials or a product expressed by the Licensed Materials including but not limited to proteins, nucleic acids or viral vectors.

“Third Party”: any party who is outside the organization or is not conducting research under supervision of the recipient of the Product.

“Third-Party Contractors”: a contractor engaged by Licensee conducting services solely for Licensee's benefit and which is bound with Licensee by a contractual relationship whose terms are consistent with and as stringent as the terms of this LULL.

**AGATHOS TERMS**

1. The Product is provided subject to a license agreement between Agathos Biologics and the Licensee. The purchase of the Product grants the Licensee the non-exclusive, non-transferable, non-sublicensable license to use the purchased Product for Licensed Research only (see definition below) subject to the conditions set out in this LULL. Licensee's right to use this Product is subject to the following conditions and restrictions:

“Licensed Research Use” means any USE FOR RESEARCH PURPOSES ONLY. No commercial use is allowed, including but not limited to:

- a) Licensing, selling, distributing, or otherwise providing or transferring the Licensed Materials to any Third Party, whether or not such transfer is limited for use in research,

except that Product may be transferred to a Third Party Contractor solely in accordance with Section 4 herein;

- b) Manufacture of a commercial product or a GMP Product, including Derivatives, Progeny, or Modifications;
  - c) Provision of commercial services to a Third Party for monetary gain, regardless of whether cash is actually exchanged, including but not limited to delivery of research results from use of the Licensed Materials; and
  - d) Use in any therapeutic, diagnostic, or prophylactic application in a human or animal.
2. Licensee acknowledges and agrees that it will not file an Investigational New Drug (IND) application or its foreign counterpart with the appropriate regulatory authority where the IND relies on Licensed Materials in any way without a signed commercial license in place with Agathos Biologics.
  3. Licensee will use the Product in compliance with all applicable laws and regulations, including applicable human health and animal welfare laws and regulations.
  4. Licensee shall be permitted to provide the Product or Progeny to a Third Party Contractor who utilizes the Product for the sole benefit of the Licensee, provided however that a legal agreement is in place and in force between Licensee and the Third-Party Contractor, whose terms will provide that the ownership of the Product is not transferred to the Third-Party Contractor and Licensee can require the return of the Product and Progeny at any time.
  5. Licensee will indemnify, defend and hold harmless Agathos Biologics and its licensors against any liability, damage, loss or expense (including reasonable attorneys' fees and expenses) incurred by or imposed upon them by your use of the Product.
  6. The terms of this LULL shall commence on the day the Product is received and continue in perpetuity. Should Licensee breach any provision of this LULL as determined by Agathos Biologics in its sole discretion, Agathos Biologics may terminate this LULL with immediate effect by providing notice to Licensee at any time.
  7. Except for the rights granted under this LULL, no other rights are transferred to Licensee in relation to the Licensed Materials. Any data generated by the Licensee using the Licensed Materials, are owned by the Licensee, subject to the use restrictions set forth herein.
  8. THE PRODUCT IS SUPPLIED "AS IS" WITH NO WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY, TITLE, SAFETY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE OR THAT THE PRODUCT IS FREE FROM ANY THIRD-PARTY CLAIMS.

9. In no event shall Agathos Biologics or its affiliates, directors, officers, employees, licensors or their respective representatives be liable to Licensee or its affiliates, whether based in contract, tort, warranty or any other legal or equitable grounds, for any loss of income, profit or savings or cost of capital of Licensee or its affiliates, for any direct, indirect, incidental or consequential damages resulting from or relating to the Product or Licensee's use thereof.
10. Upon termination of the LULL, for any reason, the Licensed Materials must be destroyed and notification of such destruction provided to Agathos Biologics.
